Below is a report to the Board of Selectmen on the Town of Mount Desert's Emergency Operation Center (EOC) briefing for 0900 hours on April 14, 2020. The EOC activation level remains at 3 which is designated as a "Standby" status as defined in the Town's Emergency Operations Plan (EOP). The Local Emergency Management Director (LEMD) continues to closely monitor the spread of COVID-19 in our area. The briefing was attended via teleconference by the Town Manager, Police Chief, Harbormaster, Public Works Director, Northeast Harbor Ambulance Service's (NEHAS) Service Chief, LEMD/Fire Chief, Town Clerk and Treasurer. The EOC briefing began with an overview of confirmed COVID-19 cases as reported by the Maine CDC. As of this briefing, there were 698 cases statewide with 5 of them located in Hancock County. Locally, MDI Hospital reports they have tested 1 Hancock County resident as positive and 2 identified as "other". The LEMD indicated that he had been tracking confirmed cases daily for the last several days and has seen an increase from about 20 to 25 / day to about 30 to 35 / day.

The EOC staff was asked to provide a brief description of their current situation and their operational objectives and any resources needed to complete those objectives. Generally, there has been little change in operational capability or staff readiness of the Town. Below is each staff members report:

Town Manager (TM) - Town Office remains in lockdown. No change in staff levels or health.

<u>NEHAS</u> - The Service Chief reports little change since last briefing. Staffing continues to be sound while maintaining around the clock coverage with either 2 on duty at the Seal Harbor fire station or with on-call EMT's available in the Northeast Harbor area. Call volume is still down a little from normal. PPE inventory is in good shape for responding EMT's.

<u>Police Chief</u> – The Police Chief indicated little to no change for staff levels or day to day operations. The PD continues their public education and enforcement efforts regarding the governor's executive orders and issues specific instructions regarding the stay-at-home order. Updated guidelines and protocols continue to be delivered by the Federal CDC, Maine Department of Public Safety and/or the Attorney General's Office on a consistent basis.

<u>Treasurer</u> - The Treasurer stated no substantial change during the last operational period. All employees who are working remotely and requested mobile hotspots have now received them. Most, if not all are now active and functioning. Pay codes have been set up for Emergency Paid Sick Leave as it relates to the COVID-19 public health emergency. PPE for the town office staff is good.

<u>Public Works Director</u> – The Public Works Director affirmed no change in staffing or operational readiness. New schedule rotation continues to run efficiently. Necessary PPE is still in good shape. The Director indicated they will be purchasing additional disinfectant in the coming week and do not anticipate any problems acquiring more from their supplier.

<u>Harbormaster</u> - Harbormaster reports no change at this time. The Harbormaster and Deputy Harbormaster are continuing their rotating work schedule to maintain CDC's recommended social distancing guidelines. Available PPE for both are still in good shape.

<u>Fire Chief</u> – Fire Chief says no major changes since last report. Staffing remains consistent. Staff has been very busy with burn permits. Changes have been made to allow daytime burning for those that purchase them online. In addition, a system has been created for those that cannot or do not want to obtain permits online, can now acquire one by calling the FD office.

<u>Town Clerk</u> – Town Clerk reported no real change in Admin. All staff remain healthy. Clerk thanked the NEHAS Service Chief for providing them with more gloves. Call volume by the general public has leveled off somewhat. Town Clerk has been engaged with working on Human Resource projects for much of the time. The Town's continuity of operations remains strong at

all levels. Workplace protective measures put into place weeks ago all have seemed to have a positive effect in keeping Town staff relatively healthy, which has resulted in a functioning town government and sustained town services. Locally, numbers of confirmed COVID-19 cases appear to be low. But we must remain vigilant. As mentioned earlier, statewide cases are rising every day. So, it is imperative for preventative measures such as safe, social distancing to continue for the foreseeable future.

#### Next weekly EOC Staff briefing will be on Tuesday, April 21 st beginning at 0900 hours.

Town Meeting has been postponed to a date uncertain due to Covid 19.

Police Department: The Town's Police Department is tasked with enforcing the Governor's <u>Essential Business Mandate</u> to ensure that all non essential businesses are complying with the order to close. Please call the department 276-5111 for more information.

Leaving garbage in these areas constitutes littering. Please use the town's curbside collection service or take your garbage to the transfer station in Southwest Harbor on Long Pond Road off Seal Cove Road. \*If you own rental property we ask that you do not open your building until the Civil State of Emergency has passed.

\*If you have recently arrived, you must quarantine for a minimum of fourteen (14) days. Do not leave your property.
