- 9- Enter payment amount.
- 10- Click Continue
- 11- Select Pay Now if you agree with the amount listed next to: Pay Now through Maine.gov (This amount includes the payment amount + Maine.gov Fee of 2.5%
- 12- Complete required fields on the payment screen
- 13- Click on Submit Payment
- 14- Keep copy of the confirmation sheet for your records.
